

CARES Act 'Quarterly Report' – March 31, 2022

Each institution applying for HEERF funds is directed to comply with Section 18004(e) of the CARES Act and submit an initial report (the "30-day Fund Report") to the Secretary thirty (30) days from the date of the institution's Certification and Agreement to the Department. The '30-Day Fund Report' information follows:

CARES HEERF Reporting Update – March 31, 2022

1. Orion Technical College (formerly Hamilton Technical College) signed and returned to the Department the Certification and Agreement on June 25, 2020 (HEERF I). The College intends to use no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students. The College signed HEERF III on September 8, 2021
2. The College received \$190,204.00 on June 30, 2020 from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students. The College was awarded \$127,966 for HEERF III on September 14, 2021.
3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of March 31, 2022, is 126 students (HEERF I). HEERF III disbursements was 1 student for \$1,100.
4. One hundred fifty-five (155) students enrolled in the 2019-2020 Spring semester filed a FAFSA and were eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.
5. 126 students received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act (HEERF I) and 1 additional student (HEERF III).
6. The College made every effort to contact all students regarding available funding and added a website devoted to the Emergency Financial Aid Grants at [https://orion.edu/wp-content/uploads/2020/08/HTC_Website - CARES ACT - to be posted by July 24 2020.pdf](https://orion.edu/wp-content/uploads/2020/08/HTC_Website_-_CARES_ACT_-_to_be_posted_by_July_24_2020.pdf). Students applied via an application found through the student finance office or sent via email and eligible students are awarded based on their Estimated Family Contribution (EFC) as calculated on their 2019-2020 FAFSA.
7. Based on the number of applicants and eligible students, awardees received \$1,100 per undergraduate student
